5K Run/Walk Course: The race will start at the Westport Light State Park restrooms (at the west end of Ocean Avenue), go east up Ocean Avenue, around the lighthouse, then west down Ocean Avenue. Next follow the beach path to Westhaven State Park and finish by returning to the starting line at the restrooms at Westport Light State Park.

10K Course: The race will start at the Westport Light State Park restrooms (at the west end of Ocean Avenue), go east up Ocean Avenue, around the lighthouse, then west down Ocean Avenue. Next follow the beach path to Westhaven State Park, go north over the dune, turn right and run east down Half Moon and back onto the path toward the lighthouse-shaped lookout tower. Run up the tower and then finish by reversing the course (including running down Ocean Avenue and around the lighthouse) and return to the starting line at the restrooms at Westport Light State Park.

Registration: Pre-registration Fee is \$20.00 and includes a tee shirt while supplies last. Pre-register in person by July 8th, at Brady's Oysters OR by mail by July 3rd, with your check payable to and sent to: Westport/Grayland Chamber of Commerce, PO Box 306, Westport, WA 98595. Event-day registration is \$25.00 and starts at 7:30 AM at the event starting area.
